Dear Students,

On account of ongoing pandemic situation of Covid- 19, the University of Mumbai has decided to conduct Regular and Backlog First Half- Summer examinations of A.Y. 2020-21 of Three Years Course, Sem 2 to Sem 6 and Five-Years Course, Sem 2 to Sem Sem 10 by online mode.

This online exam is for Regular and ATKT students. Following are the guidelines for students who will appear for this exam as per circulars issued from University of Mumbai dated 24th March, 2021 bearing Ref. No./DBoEE/ICC/2020-21/26, 8th September, 2020 bearing Ref. No. Exam / DBOEE/ ICC/ 2020-21-02 and circular issued from University of Mumbai dated 13th Sept., 2020 bearing Ref. No. Circular No. Exam/ DBOEE/ ICC/ 2020-21-04 and other circulars issued by University of Mumbai from time to time.

1. The Students must ensure that they make themselves properly aware of the syllabus, paper pattern, time table and technical platform used by the college. Thus, they must take the examinations as per the timetable schedule prescribed by the college and should make requisite arrangements (Smartphone/ Laptop/ Tab/ Desktop/ any other gadget, Internet Connectivity) to appear for the online examination.
2. Students should not resort to the use of unfair means while attempting the examination. College will initiate action for use of unfair means as per University Rules and Regulations.
3. **Since this is an online examination, there will not be any revaluation**
4. Students should refer to and follow instructions given by College and University. Do not believe in messages spread on any social media platform
5. If any student unable to appear for exam because of some genuine technical error, in that case student have to inform Asst. Prof. Mr. Ninad Shendage, Asst. Prof. Ms. Sanghpriya Shere within 3 hours of starting of the exam.
6. Mock test shall be conducted by online mode to provide practice and feel of online MCQ examination to the students.
7. General knowledge-based questions shall be asked for Mock Test. It shall be conducted only for "Practice" purpose.
8. The examination shall be of 60 marks. (20 MCQs= 30 marks, Each MCQ will carry 1.5 marks and 10 Descriptive questions= 30 marks, each question will carry 3 marks, so total 30 marks)
9. **Online exams shall be conducted from 2nd May, 2021 onwards. Time Table is attached herewith and also displayed on college website.**
10. Platform for conducting these online exams of backlog students shall be communicated to them as early as possible.
11. Entire Syllabus of subject as prescribed by Mumbai University shall be the syllabus for this online examination.
